We provide training and support for adult volunteers to enable them to deliver good guiding experiences and share good practice across the region.

About the role:

The region safeguarding lead volunteer is the main link to the safeguarding team at Girlguiding. This is a key role with a wide range of responsibilities, all carried out with confidentiality and discretion, including the support of volunteers in the region with what might be difficult conversations. You need to be a current Girlguiding member to apply for this role.

Some of what you'll do:

- Case management oversight of all safeguarding concerns, allegations and disclosures known to the region
- Collaborate and agree case management actions with the Girlguiding safeguarding team
- Frequent liaison with Girlguiding to overview all open cases and agree next steps and outstanding actions
- Work with region trustees and Girlguiding to meet reporting requirements
- Ensure the chief commissioner and trustees have awareness of safeguarding cases and currents emerging trends and themes
- Facilitate chief commissioners to maintain impartiality and objectivity regarding cases
- Offer support and guidance to a team of safeguarding assistants. Safeguarding assistants will have the responsibility for case and investigation management
- Provide support to volunteers in the region who will be asked to undertake difficult conversations, by coaching and mentoring
- · Advise on local communities and any emerging challenges
- Work with safeguarding officers at Girlguiding to reflect and learn from challenging and successful cases, sharing learning as appropriate
- Advocate safeguarding amongst the membership
- Proactively engage with a Safe Space trainers to share updates and learning to make local training relevant

What skills, knowledge and experience do you need?

- Recent practical application of safeguarding practice
- Have held a role in Girlguiding beyond unit level or ability to demonstrate knowledge of Girlguiding Volunteer structures
- Understanding of confidentiality, GDPR, consent, mental capacity and other relevant legislation
- Willingness to collaborate with Girlquiding staff and volunteers
- Ability to build and strengthen relationships with a diverse range of people
- Excellent communication skills
- Ability to organise own time/workload and achieve deadlines
